AFTER 'PAT' TOLD HER THAT HE 'DID IT.' SHE SAID THAT WHEN 'PAT' TOLD HER, SHE WANTED TO GO & CHECK ON BETTY, BUT PAT CONVINCED HER TO CALL PARAMETICS FIRST. SHE CALLED ALABASTER P.D., AND THEN WENT TO THE SCENE.

12-11-87 ABOUT 1600 HRS. I CALLED DR. EMBRY AT COOPER GREEN IN REFERENCE TO THE AUTOPSES ON THE VICTIMS. HE GAVE ME THE FOLLOWING INFORMATION:

① RONNIE PATE WAS SHOT 2 TIMES:

A) ONE SHOT ENTERED THE BACK OF THE NECK AND PASSED THROUGH THE SPINAL CORD (THE ENTRANCE WOUND WAS LARGE)

NARRATIVE

1) ONE SHOT ENTERED THE LEFT TEMPLE + STOPPED NEAR THE RIGHT TEMPLE. THERE WERE SIGNS OF UNBURNED POWDER NEAR THE ENTRANCE WOUND.

2) BETTY SNOW SWINEY WAS SHOT SIX TIMES:

A) ONE SHOT WENT IN + OUT OF VICTIM'S CHEEK AND THEN INTO VICTIM'S NECK, THROUGH THE RIGHT LUNG, + LODGED IN BACK.

B) ONE SHOT ENTERED THE Rt. LOWER CHEST AREA, PASSED THROUGH THE LIVER AND EXITED THE BACK.

C) ONE SHOT ENTERED THE ABDOMEN ABOUT 2 1/2" ABOVE THE NAVEL, PASSED THROUGH A LARGE VEIN + LODGED IN THE BACKBONE.

D) ONE SHOT ENTERED THE BACK, PASSED THROUGH THE RIGHT LUNG + INTO THE HEART.

E) ONE SHOT ENTERED THE LOWER BACK AT THE WAIST, TRAVELED TO THE PELVIS AREA.

F) ONE SHOT PASSED IN + OUT OF THE RIGHT SIDE OF THE BUTTOCKS.
