AMENDED NOTICE OF AMENDED NOTICE OF APPEAL

Notice is hereby given that Kerry Craig Walker, Plaintiff in the above-styled case, hereby appeal to the Georgia Court of Appeals. On the 2nd day of August 2010 an **ORDER** was signed by the **Honorable Judge Adele P. Grubbs** stating:

“The Plaintiff having timely filed a Paupers Affidavit as to his Appeal in this matter;

IT IS HEREBY ORDERED AND ADJUDGED that the Pauper's

Affidavit is in correct form and the Clerk of the Superior Court of Cobb County is directed to transmit the case to the Appellate Court.”

No portions of the filed documents shall be omitted on appeal. These documents shall include the **Original Filing** of said lawsuit, **Notice of Appeal, Amended Notice of Appeal, Argument for Appeal, Pleading and Response to Hearing on Why Plaintiff's Appeal Should Not be Dismissed, ORDER** issued by the **Honorable Judge Grubbs** on August 2, 2010, and **all other documents related to this case filed in the Cobb County Superior**

Court. A **RECORD** of all documents submitted to the Appellate Court or any **SUPPLEMENTAL RECORD** of such documents are to be sent to Plaintiff at no cost as per the Court approved Paupers Affidavit signed by the **Honorable Judge Adele P. Grubbs** and filed in the Cobb County Superior Court on August 4, 2010. There are NO TRANSCRIPTS to be submitted in this case as NONE were taken.


In a related case in Cherokee County Georgia (Case No. 07-CV-3325) an **ORDER** by the Court was signed on August 23, 2010 by the **Honorable Judge Murphy C. Miller** and the judge's Order states:

"The Court **GRANTS** Plaintiff's Request to have the September 25, 2001 arrest **EXPUNGED** from his record. It is further **ORDERED** that any warrants, fingerprints, or other items collected in connection with the September 25, 2001 arrest be purged from the criminal records..."

The Plaintiff's false arrest was a result of a fake crime report filed by the Defendant and because of the Defendant's unlawful, unjust, and fraudulent actions. This case continued on for years as a result of the Defendant's continued demented actions of deceit and perjured testimony to law enforcement, the prosecution, and everyone related to this case. 
