**Re: Civil Action File No. 07-1-10459-42, Kerry Craig Walker vs. Jacqueline Wagner**

Dear Ms. Lanham,

On March 24, 2010 you sent Kerry Craig Walker, pro se Plaintiff in CIVIL ACTION FILE NO. 07-1-10459-42, Notice of Trial Court Cost by Certified Mail (No. 71603901984972585066) demanding that pro se Plaintiff pay \$310.00 or his Appeal could be dismissed by the Cobb County Court and not forwarded on to the Georgia Court of Appeals.

Pro se Plaintiff had mailed a **Pauper's Affidavit** on March 6, 2010, in legal order, signed and notarized, and filed in Cobb County Superior court on March 10, 2010, requesting Plaintiff's right to file said appeal in the Georgia Court of Appeals without having to pay filing fees.

The facts show that Kerry Craig Walker, pro se Plaintiff in this 1.5 million dollar lawsuit, has gone through hundreds of thousands of dollars in cash and assets over the past 9 years fighting this case because of his false arrest on September 25, 2001 from a fake crime report filed by Defendant Wagner and her continued deceit over the course of 50 months, until all charges were formally dismissed by the Honorable Judge Jackson Harris on November 23, 2005. A lawsuit under Civil Action File No. 07-1-10459-42 was timely filed by Plaintiff on November 20, 2007, within the two (2) year statute of limitations.

On August 20, 2010 Plaintiff had a Hearing on his Expungement Claim and there was no opposition from Counsel for the Defendants. An **ORDER** was issued on August 23<sup>rd</sup>, 2010 by Judge Murphy C. Miller which **GRANTED** Kerry Craig Walker's expungement request to have his September 25, 2001 arrest expunged from the record. This **ORDER** signed by Judge Murphy C. Miller further **ORDERED** that any warrants, finger prints, or other items collected in connection with the September 25<sup>th</sup>, 2001 arrest be purged from the criminal records.

Because of the unlawful acts and demented actions of Defendant Wagner, and her continued efforts to cover up for her violent, unlawful, and deceitful actions, Kerry Craig Walker, pro se Plaintiff, now suffers many hardships, especially financially.

Under prejudice by the court, Mr. Walker continued to fight for his right for appeal and for a Pauper's Affidavit to be granted and Plaintiff attended hearings concerning his appeal as well as a separate **Hearing to Consider the Merits of Pauper's Affidavit**.

On August 2, 2010 said Pauper's Affidavit filed in **Civil Action File No. 07-1-10459-42** was **GRANTED** by Judge Grubbs and the **ORDER** stated that the Pauper's Affidavit was timely filed and it was **ORDERED AND ADJUDGED** that the Pauper's Affidavit is in correct form and the

Clerk of the Superior Court of Cobb County is directed to transmit the case to the Appellate Court.

To date I have received no record of such transmittals.
