It is with a heavy heart that I write you today. I understand that none of us are perfect and we are all fallible human beings, but surely it is possible to live a life of absolute goodness and love.

It turns out that my prayers and hopes were in vain, and my efforts to let the truth shine down on the facts of this case have been met with continued deceit and corruption. The judicial process in Georgia is so deeply corrupted. Not superficially corrupted, but deeply corrupted. In actuality the state of Georgia, where I was born and raised, has been deeply corrupted and operating under the conditioning and illusions of religion for the life of the state's history under the rule of my ancestors. In a legal system so latent with egos, incompetence, stupidity, corruption and deceit, it is difficult to draw a line where these elements begin and end.

In over two years since my lawsuit was filed not one single hearing has been held so that the facts of this case could be presented. My side of the story has never been presented in court in the nine (9) years that this case has been in legal process. My powerful and steadfast witnesses that include an honest attorney, a good citizen, a honest police officer, and an expert witness, have never been heard in a judicial setting. The many tapes that I have recorded since the beginning of this case and the video evidence have never been presented in court.

In studying the history of Georgia since my birth, I have learned that I was, in actuality, in fact, and in truth, born into a state of both deeply corrupted politics and deeply corrupted judicial processes. I have studied some thirty five cases of actual innocence in Georgia, with clear evidence of innocence, but with no hope for justice. The bizarre and complex immunity laws and contradicting legal jargon that is used in modern law is a disgrace to any intelligent human being.

History tells us that the Georgia legislature and the people of Georgia were the catalyst for the ethnic cleansing of an entire race of people. It is ironic that a county where I have witnessed deeply rooted corruption, the tainted use of power, and a brotherhood of deceit, is so named after the people it caused to endure so much suffering, pain, and death. My family and I have suffered likewise.

Having read and studied your **Order on Motion for Judgment on the Pleadings** the evidence of judicial corruption and deceit are clear. Virtually every fact relating to this case is wrong and the dates cited in this Order are wrong. This Order is further evidence of how the profession of lawyer, policeman, and politician have become detrimental to man and a disgrace to society.

I have a loving wife and a loving family and we have suffered beyond words and we now struggle to survive, so please do not use some narcissistic position of power to bring more harm to us. Because of this case and my struggle to survive, I have no money to pay an attorney, so I have no choice but to represent myself.

You granted me permission to seek expungement from my false arrest for several misdemeanors and from a tainted indictment for aggravated assault in Cherokee County, Georgia caused by the evil mindset of Preston Peavy. This alone is evidence that my claims are true.


In our telephone conference call, I made it clear that my case had been in the hands of two judges for two years before getting to you and that it appeared to me to be a case of judge shopping. Now it is clear that you were chosen to dismiss my case without getting the facts straight and without a single hearing to hear the facts, or the witnesses, or the overwhelming evidence that would substantiate my complaint. The fact is my case should have been heard by a jury, and eventually my case will be presented to a jury and the world will know the truth.

I have the legal right by law to appeal your Order to the Georgia Court of Appeals and to file an argument within ten (10) days of the date of my appeal, and to pursue this case in every court thereafter.

I will continue to pursue every non-violent means to let the truth shine on the actuality of what happened to me and my loved ones. It is my right granted by this Energy behind all Creation and by our Constitution to express how I see things and to present my argument. I will do whatever it takes to bring out the truth and to allow the light to shine on this case of malfeasance and injustice and on our deeply corrupted and broken legal system.
