Thank you for your order setting a case status telephone conference. Because of this case, I now only have a pay by the minute (no contract) phone and that number is **423 260-5803**. I will attempt to be on my brother's (Wyn Walker) phone (unlimited minutes) at the time of this conference and that number is **423 320-3008**.

Please make the first attempt to reach me on the **423 320-3008** number, and if you cannot reach me at that number please use **423 260-5803**.

I will be available on Monday, the 4th day of January 2010 at 2:00 p.m., or at any subsequently arranged time, for this telephone conference.

I want you understand that the former Detective Peavy went far beyond mere wrong doing, and in his unscrupulous back to back dishonest attempts to manufacture my guilt he violated my rights and obstructed the law.

No disrespect to Your Honor, but your profession is not what it should be, but what profession is? The three professions of lawyer, soldier, and policemen have become detrimental to man and a disgrace to society—and I would include the politician. I can only hope and pray that you will seek the truth in this matter and are not corrupted and have no motives in your observations of the actual facts in this case of corruption, obstruction and deceit.

I was born and raised in the state of Georgia, and the actions of certain officials in Cherokee County during my long four year nightmare were deplorable. Even the media in this town covered for their corruption. My health has been adversely affected, my two brothers health has been affected, especially my younger brother, and my dear, sweet, and patriotic mother died under the duress and confusion of this bizarre case of manipulation of evidence to manufacture the guilt of an innocent man. If the state had had their way I would be locked up in prison for crimes I did not commit and was in actuality the victim of crimes committed by an unbalanced bipolar sociopathic woman, who appears to be pathologically dishonest.

Judge Murphy, I filed this lawsuit to bring closure to what has happened to me, and to bring out the truth about our broken judicial system. There are thousands of men and women in prisons or locked up in jails in this country that do not belong there because of our unjust and broken legal system. Corrupted officers of the state should not be protected by some complex, absurd and unjust immunity laws. By filing this lawsuit I have the right to a jury trial in front of a fair and impartial jury so that the facts can be presented and the witnesses and recordings heard in this complex case of a detective tampering with evidence in order to manufacture the guilt of an innocent man, a man who was in fact the victim of domination, control, threats and violence.

I have had problems in my distant past, but I turned my life around on April 12, 1992 and I have been clean and sober ever since. I even stayed clean and sober through this ordeal, but my life has been ruined in so many ways. I have applied for dozens of jobs and gone through dozens of interviews, just to be turned down for work because of what I have gone through since my false arrest on Sept. 25, 2001 from an assault I endured on Sept. 16, 2001.


Because Detective Peavy never interviewed the only witness at the scene, altered a transcript of a recorded conversation with the alleged 'victim' that exonerated me (and then "lost" the tape of this conversation), ignored exculpatory evidence and then altered this key piece of evidence (that an expert witness and an attorney saw beforehand), and tainted evidence for a Grand Jury, I was wrongly indicted for aggravated assault. This arrest record (although I was never arrested for this upgraded charge) has made it very difficult for any corporation to hire me. I was recently hired by Advance Auto Parts in Dayton, Tennessee, but now this record of aggravated assault prevents me from driving for them even though I have a perfect driving record and this charge was formally dismissed by the state. This is why I seek to have any record of my false arrest and the tainted indictment expunged from the record.

I lost my custom home that I personally designed and physically built on property that was dear to my heart and I have lost everything else after my cabin was trashed out unjustly by the sheriff's department through Wells Fargo bank even though legal signs were posted on the property stating that the property was involved in a legal dispute and contact information for my attorney and myself were clearly posted on the property and the building. I now have a lawsuit pending against the bank. I have lost access to my timeshare because I could not pay the maintenance fees and virtually everything that I owned is gone or ruined.

In a matter of years I turned my life and my credit around and I was able to put my home into my name and to obtain credit and credit cards and was a productive member of society. Now my credit has been ruined and the credit card companies have judgments against me. In 2001 I had obtained good health insurance with medical and dental coverage, but because of this battle I struggled to pay the premiums, and finally in 2004 I had to give up my health insurance.

I fought against a very crooked detective and corrupted legal system in Canton, Georgia, and I won the long battle and all of my charges were finally dismissed. Although the charges were dismissed on the 23 day of November, 2005, I did not receive the order by mail until December 19, 2005, over two weeks after my mother's death.

I look forward to this conference call and to communicating with you about my case and the *truth* of what happened to me and my family.
