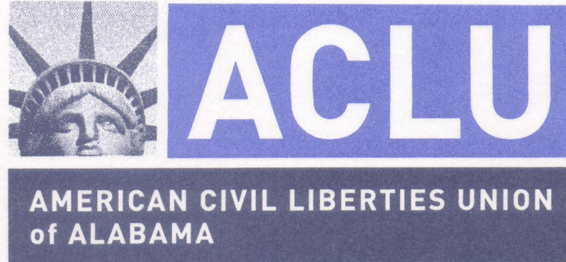

Dear Ms. Swiney:

We have received your recent letter requesting assistance. We regret that the American Civil Liberties of Alabama cannot help you at this time. Unfortunately, the ACLU of Alabama does not have the resources to pursue every request for assistance, even when a serious civil liberties issue is present. Our decision to turn down your request does not mean that your case lacks merit.

All legal claims are subject to time limitations. Failure to file suit or take other necessary steps within those time limits could result in your losing the right to bring a claim. Therefore, you should act quickly if you wish to pursue this matter. If you want to pursue your claim further and do not have an attorney, you may wish to call the Alabama State Bar Lawyer Referral Service at 1-800-392-5660. If you have little or no income, you might be eligible for free legal assistance from Legal Services. A list of their offices is enclosed.

We are sorry that we cannot help you, and wish you the best.
